- 1. The Raffle will be conducted on October 29, 2022.
- 2. Purchasers of raffle tickets must be at least 18 years of age at the time of the purchase; however, an adult may put a minor's name on the ticket stub and prizes may be awarded to a minor, subject to any applicable local, state and federal taxes and compliance with any local, state and federal applicable laws.
- 3. The price of the ticket is 1 for \$125 or 2 for \$200 or 3 for \$250 (4 for \$400, 5 for \$450, 6 for \$500 or 12 for \$1000.) Additional price option: 40 for \$3,000, one payment required.
- 4. An Early Bird Raffle drawing will take place Saturday, October 8, 2022, in the St. Francis High School. All tickets stubs will be deposited in the raffle drum and a single ticket will be drawn, with at least two representatives present.
